It is for the information of all the candidates who have applied for the post of Subject Specific Teachers vide Notification No. Edu/RMSA/Adm/24791-824/2017 dated 11/03/2017 and for Programmer/Assistant Programmer vide Notification No. Edu/RMSA/Adm/05/2017 dated 19/06/2017 and Draftsman vide Notification No. Edu/RMSA/Civil/02/2017 dated 22/07/2017 that their written test shall be conducted on 19th of November 2017 at Jammu and Srinagar. The candidates can download their Admit Cards from the Official website of RMSA i.e. www.jkrmsa.com with effect from 04/11/2017. The details regarding Examination Centre, Time of Examination and venue etc. shall be available on their respective Admit Cards.

Some of the candidates have been found ineligible on account of deficiencies with respect to their credentials and other requirements as required as per the notification issued dated 11/03/2017. The candidates shall be required to come up with the relevant Original documents alongwith self-attested hard copies at Directorate of RMSA, Baghat-e-Barzalla behind Bone and Joint Hospital, Srinagar/ Directorate of RMSA, Malik Market, Opposite Gurudwara, Jammu upto 05:00 pm from 28/10/2017 to 04/11/2017 (within 7 days) from issuance of the notification for clearance of their deficiencies after which no claim shall be entertained and the candidates will not be allowed to sit in the examination.
