Madam/Sir,

In continuation to above reference it is stated that RMSA is a flagship programme implemented in the state for supporting and upliftment of Secondary Education Sector and to bring excellence in the School Education Department. The various activities approved by PAB are within the sealing cost, within which the activities are to be completed.

2. The TA/DA and training cost including other allied expenditure is to be met out of the approved unit cost. It has been observed that the approved unit cost is not sufficient to meet the TA/DA charges of the trainees in general and in particular in districts which remain cut off during the winter from Summer Capital and Winter Capital due to closure of the roads.

3. Accordingly a general direction to keep the trainings within the approved cost the concerned Chief Education Officers and DIET Principals must send the trainees to the training centre on the basis of sharing of the public transport and avoiding aerial route where ever possible. Pertinent to mention that CEOs and DIET Principals are having departmental convenience the same may be used to make effective the travelling expenditure.

4. In case accommodation is needed for attending the training programme the trainees may avail the facility of the Teachers Bhawan at Srinagar and Jammu. In case the Teachers Bhawan is not available the same may be arranged at Circuit House, Jammu/Srinagar. However if the trainees take accommodation in some private hotel the reimbursement shall be as per the charges of the Circuit House. It is further reiterated that the accommodation may be taken on sharing basis.

4. DRMSA has provided indicative list of expenditure to all the training agencies with the request to adhere to the suggestive areas of expenditure for keeping the activities within the approved cost. The same is enclosed as annexure A to this letter.
